

Sajjad has significant experience in corporate insolvency and restructuring having been appointed to several highprofile assignments over the years.

In advisory work, Sajjad has led numerous assignments relating to business valuation; such assignments are undertaken in connection with i) business acquisitions/divestments, ii) business restructuring, or iii) commercial disputes which often involve business (under or over) valuation issues. The latter usually involves writing expert reports and testifying in court.

In acting as an expert, he has assisted and advised in various types of disputes, including construction claims, minority rights issues, commodity futures trade disputes, lender liability claims and post- merger/acquisition disputes. Business valuation is very often an underlying cause of the disputes.
